### **SHOOTING COMPLEX RULES AND REGULATIONS AS OF AUGUST 25, 1997**

1. Shooting hours:
  - Rifle, pistol, archery, day light year around
  - Trap, skeet, and sporting clays see posted shooting times.
2. No fully automatic weapons or alcohol allowed in any firing areas.
3. No vehicles outside parking areas. They must all stay on roads. Golf carts or ATV may be used on cart paths in rifle or shotgun areas only.
4. All firing must be done from established shooting positions. No foot traffic forward of firing positions if firing in process. No loaded firearms behind firing lines. Violators subject to immediate expulsion.
5. Ranges:
  - Rifle range has two 50 yd., one 100 yd., one 200 yd. and one 300 yd. targets impact areas
  - Pistol range to the North of the rifle range has one range for 22 cal. rifle or pistol only No Exceptions
  - The remaining two pistol ranges are for all other pistol bores. No rifles of any type to be used in these pistol areas
  - Rifles using pistol calibers will be allowed in pit areas & indoor range.
  - Competition range will only be used in sanctioned matches, group training exercises, or match practices. The Board of Directors must approve the use and scheduling of the competition range.
6. Absolutely no glass, cans, boxes, paper plates or other homemade targets are allowed. All brass, hulls and trash must be picked up.
7. Guests are allowed at Range, but they must reside out side of Goshen County. They must sign in with a paid member and leave the \$5.00 fee at sign in area.
8. All paid members must sign in and out... No Exceptions.... at sign in area, and last member out of complex must lock the gate. The gate combination is given to each paid member with his annual card.
9. All members are asked to maintain the integrity of the range in regard to clean up, repairs and make the board of directors aware of any problems with the complex and or other members questionable safe shooting practice.
10. This club belongs to each and every member, with an 8-man Board of Directors to over see the operations. Your volunteer service is appreciated and always welcome.

11. Misuse of the shooting complex, unsafe or haphazard gun safety as well as not following the rules and regulations are grounds for expulsion
12. No one under 18 years of age may be on grounds without a paid adult member. Adult supervision is required at all times.
13. Associate memberships are available for a **\$250.00** annual fee with Board of Directors approval. Example: Hunter Safety, 4-H shooting, WMCI, Boy Scouts, Schools and Wyoming Game & Fish. Highway State Patrol is to be determined by the board.
14. Guest fees are **\$5.00** per day and must be paid at time of sign in with your paid member. See Rule 7.
15. Annual membership is from August 1 through July 31 of the following year, **\$100.00** for each member or for a Family. All supervised children under 18 years of age and with a paid member is free. Prorating of membership dues available to new members only.
16. Memberships can be purchased online from the Sportsmen's Club Website.

We do add 3.5% to cover the processing fees.

17. Partial year Feb. through Aug 1<sup>st</sup> will be prorated for NEW members only.  
 This fee is for the prorated year and the next full year.  
 Single and/or Spouse.....**\$9.00** per Month  
 Partial charge must also include the next year membership in advance.  
**\*NO EXCEPTIONS\***

17. The Board of Directors may charge a late fee of **\$20.00** for renewals not paid by Oct. 15.
